DESCRIPTION OF SERVICE PROVIDED:

Service Provider agrees to mow and maintain the properties for the Township in accordance with the specific scope of work and within the specific timeframe as provided in the attached Claridon Mowing and Maintenance Service Quote, attached hereto and incorporated herein. In addition, the following shall be attached hereto: General Liability Insurance Certificate naming Claridon Township as an additional insured; Workers' Compensation Insurance Certificate; Certificate of Unresolved Findings from the Auditor of State's Office; Personal Property Tax Affidavit. Service Provider shall defend and indemnify Township for any and all claims arising out of the performance of Service Provider under this Agreement.

PAYMENT FOR SERVICES PROVIDED:

In accordance with the attached Quote, the Township shall pay Service Provider for such services in eight (8) equal monthly payments from April, 2017 through November, 2017. Any and all additional services not specifically stated must be expressly authorized by the Township board of trustees or its authorized designee in writing and upon such authorization, the Township shall pay upon completion, net 30 days.

TERM OF AGREEMENT:

This Landscape Maintenance Agreement is in effect for 2017 only, and shall not be renewable.

GOVERNING LAW:

Any and all disputes arising under this Mowing and Maintenance Agreement shall be brought in a court of competent jurisdiction in Geauga County, Ohio. The laws of the state of Ohio shall govern this Agreement.

TERMINATION:

This Agreement may be terminated for any reason by Township upon providing thirty (30) days written notice to Service Provider.

ENTIRE, SOLE AGREEMENT AND MODIFICATIONS:

The Parties hereby agree that this Landscape Maintenance Agreement constitutes the entire agreement between the Parties, that no other agreement between the Parties exists relating to the landscaping maintenance services referenced herein, and any change or modification to this Mowing and Maintenance Agreement shall be made and agreed to by the Parties in writing.
