2013 Budget

Claridon Township has been approved to receive \$706,802 in taxes and other sources for the fiscal year 2013. The General Fund will receive \$168,685; the Road and Bridge Fund will receive \$191,587; and Fire Levy Fund will receive \$272,930. The remaining \$127,600 is spread out through other minor funds of the Township. ●
