CLARIDON TOWNSHIP BOARD OF TRUSTEES' RESOLUTION TO SUSPEND COLLECTION OF CLARIDON TOWNSHIP'S 2.3 MIL FIRE & EMS 5-YEAR LEVY AUTHORIZED BY VOTERS ON NOVEMBER 6, 2018 BY A DOLLAR FOR DOLLAR AMOUNT OF CLARIDON TOWNSHIP'S 2.0 MIL FIRE & EMS RENEWAL LEVY (CONTINUOUS PERIOD OF TIME) AUTHORIZED BY VOTERS ON NOVEMBER 5, 2019.

WHEREAS, Claridon Township is currently collecting on a 2.3 mil Fire & EMS tax levy authorized by voters during the general election held on November 6, 2018 which provides funding for the operation of the Township's Fire and EMS operations provided and authorized in ORC 5705.19(I); and

WHEREAS, at the regular Trustee meeting on April 15, 2019, the Board of Trustees unanimously passed a resolution in which the Board committed to partially suspend collection by a dollar for dollar amount of the said 2.3 mil levy should the voters in the Township approve the renewal of the said 2.0 mil Fire & EMS levy for a continuous period of time; placed on the ballot of the November 5, 2019 general election; and

WHEREAS, voters authorized the renewal of the said 2.0 mil Fire & EMS levy for a continuous period of time which was first authorized by voters in 2005.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of Claridon Township, Geauga County, Ohio, during a special meeting session on November 14, 2019 at the Administration Building located at 13932 Mayfield Road in Claridon Township, that **effective for the 2020 collection year and ending upon future resolution by the Claridon Township Board of Trustees** said 2.3 mil Fire & EMS levy be suspended by a dollar for dollar amount of the said 2.0 mil levy.

BE IT FURTHER RESOLVED that the effective period of time shall not be changed until the current Fire & EMS contracts with Chardon Fire Department and Burton Fire Department expire, at which time whether in part or in whole, only the necessary amount to satisfy new contracts shall be considered for collection at that time.

BE IT FURTHER RESOVED that the Township Fiscal Officer is authorized and instructed to deliver a certified copy of this resolution to the Geauga county Auditor's Office to ensure the accuracy of relevant tax rates and values for the 2020 tax collection period.


