# <u>Geauga Public Health to Attend Trustee Meeting - Claridonites Encouraged</u> <u>to Attend</u>

Kristi Pinkley of Geauga Public Health will be attending our Trustee meeting on April 15.

The health department has begun the process of rolling out a state-mandated Operation & Maintenance program for septic systems in the county and the first residents in Claridon will be affected starting in late Spring, 2024. Geauga Public Health wants Clardonites to know what to expect. Attend the April 15 trustee meeting and find out. The meeting starts at 6:00pm and is held at the Administrative Building.

#### **Claridon Trustees Resolved to Prohibit Commercial Cannabis**

On January 15, 2024, at a regular trustee meeting, trustees resolved to prohibit all aspects of commercial cannabis within the Township.

As of now, no one knows exactly how this new statute will look and operate as the state legislature has not yet passed any rules that govern commercial cannabis operations. Some townships are prohibiting commercial cannabis temporarily simply because of this unknown.

As far as Claridon is concerned, Trustees received over 70 petitions from residents to pass this resolution. Further, although this issued passed in the state and in our county, it failed in Claridon. In an effort to perform the will of Claridonites, the trustees passed a resolution to prohibit all aspects of commercial side of cannabis.

This commercial prohibition has nothing to do with the personal use of cannabis. The personal growing and using of cannabis, with limited restrictions (reference the ballot language), is now protected by state law.

#### We've Been Saving

For several years, we've been intentionally saving for a few things. Some of them are ready to happen;

New Roof - We are receiving bids for a new maintenance building roof. 5 years ago, we recognized the roof (it's still the original roof) was in bad shape. At the time, we didn't have the money for a new roof so, we just kept fixing it. After 5 years, we saved enough money. We plan on having a brand new roof sometime this year.

New Garage Door Panels - Just like the maintenance building roof, several of the large overhead garage door panels are beyond repair. We are set to replace them with new.

New Truck - The township has been saving for a new truck. The truck we will be purchasing is a Mac. It is the largest non-CDL size allowed. We are excited to finally be able to afford this truck.

Town Hall Roof - An old slate roof sits atop our town hall. It's the original roof of this very old building. In keeping with the character of the building, the board of trustees decided to keep it and simply perform repairs as needed. The township saves a certain amount each year to do this.

Cemetery Restoration - Many of our monuments and stones are in desperate need of repair and have been for a long time so, we've been saving for 5 years. We now have the funds to perform \$80,000 worth of restoration. The restoration includes fixing old foundations, resurrecting fallen monuments, fixing broken monuments, lining up rows more precisely, cleaning the stones and more. This should cover the entirety of Center Cemetery plus, all of West Cemetery OR, part of East Cemetery. We are still discussing West verses East. If you have any questions or insights, contact me. All this work will be done this year.

Hall Road - Although we did not specifically save to resurface Hall road (our current lowest rated road for quality), we did over-save for Taylor Wells road so, we have significant funds left over. Further, we've been cautious in spending for the last 5 or 6 years because we do not get sufficient income for our roads. Also, the lowest bid for Hall road came in over \$35,000 less than projected (love that!). With that said, we're happy we have enough funds to resurface Hall road this year. Ronyak Brothers won the bid therefore, is expected to be issued the contract. The unofficial cost is \$265,000.

### **Trustees, Fiscal, Zoning Inspector....further education**

Each February, the Claridon Fiscal, Zoning Inspector and Trustees travel to Columbus for the Ohio Township Association Winter Conference. The conference is at the Greater Columbus Convention Cneter. It offers a trade show and lots of work session classes... everything from Zoning, fiscal items, cemeteries, roads, proper meeting procedures, communicating with the public and press, i.t. and much, much more. It is highly beneficial to helping us serve our community more efficiently, accurately, transparently and fiscally. The Ohio Township Association exists to protect and support local government, which brings me to the next topic...

### A Zoning Take-over Attempt?

Certain groups, want to build more homes. Specifically in central Ohio. It is under the guise of resolving the affordable housing crisis. So, what's standing in their way? The answer is local zoning regulations. For instance, in Claridon, only one home can be built on a 3 acre lot (this regulation helps Claridon remain rural). Think about how many <u>more</u> homes one can put on a 3 acre lot if that regulation was not in place. The proposal to take away zoning authority from townships and give it to the state is in the Senate Select Committee right now. The idea is to give zoning authority to the state which means all township zoning may be wiped clean so the state can draw up universal zoning for everyone. From agricultural exemptions to forcing townships like Middlefield to have zoning to changing the very character of our community, the negative implications are vast.

Rest assured, the Ohio Township Association and Geauga County is leading the fight to thwart this effort. I have over 50 zoning personal and trustees from across the county meeting on a regular basis. In fact, the Farm Bureau will be at our next meeting. They will prove to be a powerful ally. We will get other influential groups on board as well as hundreds of township. I not only want to thwart this effort, but, by the time it's said and done, I want to send these groups and the state a very clear message; 'You can not steal authority away from townships!' Local government is the purest form of American democracy and it will not be trampled upon!
