PUBLIC COMMENT

Several residents reported that they are concerned with the placement of mailboxes and the driveway aprons on Taylor wells Road North. They also mentioned the center line on the road is crooked. Mr. Arnold brought pictures to share with the BOT showing these issues.

Mr. Tiber and Mr. Miller will assess these claims on Thursday, July 20 by way of a drive-around. They will collect addresses of aprons they feel should be addressed as well as assessing the road itself. They will create a punch-list and have a drive-around with the Engineer. If anything on the punch list is independent of the original contract, they will get quotes to perform the work and report back at the next BOT meeting. Mr. Tiber will also check with GCEO in regards to the mailboxes being too close to the road.

Mr. Dave Carlson also reported that he is having issues with his neighbor blowing fog horn and shooting gun when his dog barks. He fears for his family and grandchildren when this happens.
