Mr. Sherman will be obtaining other quotes.

Mr. Burzanko added that he will be contacting the Independent Tree services to find out when the removal of the corner park/cemetery trees will be taking place.

BUILDINGS

Mr. Sherman reported that Town Hall emergency furnace repairs were recently made by JKL Mechanical.

ROADS

The BOT discussed the bid dates for the upcoming shoulder widening and asphalt resurfacing of sections B-C of Taylor Wells Road (north), TR-0113 project. Final approval of the time frame and exact dates will be made during the 2/6/2023 Trustee meeting.
