December 11, 2023

The regular meeting was called to order at 6:00 pm with the following members present: Trustees- Cooper Sherman, Roger Miller, Jonathan Tiber, and Fiscal Officer- Paula J. Hietanen.

Ms. Hietanen took roll call for attendance. Mr. Sherman, Mr. Miller and Mr. Tiber responded here.

GUEST

Chief Geiss, Chardon Fire Department, was in attendance to give a brief overview of YTD calls and recent happenings within the CFD. He reported that so far this year CFD responded to 257 calls in Claridon (252 calls in 2022), and 2183 calls for all entities that CFD covers.

Chief Geiss spoke about several safety grants they applied for, in order to purchase a new cot and load system, new gloves and hoods, and a new ladder truck.

The BOT and Chief Geiss discussed the desperate need for a new ladder truck, in order to replace the current truck which is already 21 years old. The BOT presented Chief Geiss with a letter of support/need from Claridon Township to be filed with the grant application. Without financial support from the grant funds, Chardon Fire Department will not be able to purchase a new \$2.2 million ladder truck.

ZONING

Mr. Alusheff presented the BOT with a zoning report via email.

Mr. Tiber briefly spoke about a personal camera that was installed on a utility pole by Mr. Serge (at the end of his driveway), in order to monitor the property across the street in hopes of possibly catching and illegal activity. Photos of the property from the cameras are being emailed to the Zoning Inspector for his review. After inquiring with the Sheriff's office regarding the camera and Mr. Serge's criminal past, Mr. Tiber was informed that it is not illegal to install a camera (even as a registered sex offender), but it is disrespectful. A call has been placed with the utility company as well, since the pole being used for the installed camera is owned by the utility company, and not by Mr. Serge.

December 11, 2023

Mr. Tiber reported that all Claridon Township residents will be receiving a Land Use Survey letter in the mail, in order to assist the Geauga County Planning Commission, Claridon Township Zoning, and Claridon Township Land Use Committee with updating the current Land Use Regulations (last update done in 1996).
